**CHANGES TO BE MADE ON OUR ARTICLES OF INCORPORATION**

**ARTICLE 1: NAME**

The name of this non-profit church corporation shall be CARIS Christian Fellowship, Inc.

**ARTICLE III: PURPOSES**

To provide basic Biblical teaching, and discipleship to all members.

**ARTICLE IV: Election and/or appointing of Directors**
