## AMENDMENTS TO THE ARTICLES OF INCORPORATION FOR HAWKSRIDGE PROPERTY OWNERS ASSOCIATION, INC.

Article VII of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following Article VII. Note: Substantial Amendment of Article VII. For present text see existing Articles of Incorporation.

#### BOARD OF DIRECTORS

- (A) The affairs of the Association will be administered by a Board of Directors consisting of the number of Directors set in the Bylaws, but never less than three (3), and in the absence of a Bylaw provision shall consist of five (5) Directors.
- (B) Directors of the Association shall be elected by the members in the manner determined by the Bylaws. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided by the Bylaws.
