ARTICLES OF MERGER OF SHANNON LAKES PROPERTY OWNERS' ASSOCIATION, INC. INTO LAKESIDE ESTATES MASTER COMMUNITY ASSOCIATION, INC., A FLORIDA NON-PROFIT CORPORATION

Pursuant to the provisions of Section 617.1105, Florida Statutes, the undersigned Florida Non-profit corporations adopt the following Articles of Merger for the purpose of merging them into one corporation:

1. The following plan of merger was approved by the members of each the undersigned corporations in the manner prescribed by the Florida Statutes, the Articles of Incorporation and the Bylaws of each of said corporation, to wit:

As set forth in Plan of Merger, attached hereto as Exhibit "A" and by this reference expressly made a part of these Articles of Merger.

- 2. The name of the following corporation which is the party to the proposed merger is Shannon Lakes Property Owners' Association, Inc.
- 3. The surviving corporation in the case of the proposed merger is to be Lakeside Estates Master Community Association, Inc., a Florida nonprofit corporation.
