### PLAN OF DISTRIBUTION OF ASSETS

THIS PLAN OF DISTRIBUTION OF ASSETS (this "Plan") is made and approved by the Board of Trustees of PEMBROOK FOUNDATION, INC., a Florida not-for-profit corporation (the "Corporation") this 20th day of January, 2012.

- A. At a Special Meeting of the Corporation's Board of Trustees (the "Board") held on January 20, 2012, the Board voted to formally ratify the action of the Corporation to distribute the assets of the Corporation by December 31, 2011 and dissolve pursuant to §617.1402, Florida Statutes, and distribute its assets in accordance with the following Plan of Distribution of Assets.
- B. As such, the Board hereby approves, authorizes and consents to the following Plan of Distribution of Assets in accordance with §617.1406, Florida Statutes.
  - 1. The Corporation has made arrangements for all liabilities and obligations of the Corporation to be paid and discharged, or adequate provisions otherwise made therefor.
  - Assets held by the Corporation upon condition requiring return, transfer or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements;
  - 3. Assets received and held by the Corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the Corporation;
  - 4. Other assets, if any, shall be distributed in accordance with the provisions of the Articles of Incorporation or the Bylaws to the extent that the Articles of Incorporation or Bylaws determine the distributive rights of members, or any class or classes of members, or provide for distribution to others; and
  - 5. Any remaining assets shall be distributed to persons, trusts, societies, organizations, or domestic or foreign corporations, whether profit or not for profit.
