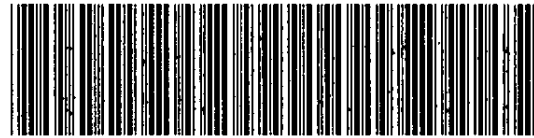

OF JOYCE FROHLICH MINISTRIES, INC. A FLORIDA NOT-FOR -PROFIT CORPORATION

ADOPTION OF AMENDMENTS

Add to ARTICLE FIVE - OFFICERS – Section Five. President 5 5b

5 5b The Corporation finds its headship under the Lord Jesus Christ and in its President. The President is the Chief Executive Officer of the Corporation. She shall preside at all meetings of the Board of Trustees and shall see that all orders and resolutions of the Board are put into effect. She shall execute in the name of the Corporation all deeds, bonds, mortgages, contracts, and other documents authorized by the Board of Trustees. She shall be ex-officio member of all standing committees, and shall have the general powers and duties of supervision and management usually vested in the office of president of a Corporation.

Add to ARTICLE SEVEN – INDEMNIFICATION AND INSURANCE – Section 8

The President is the administrator of the Corporation. She is ultimately responsible for all day-to-day administrative decisions. She shall be designated attorney-in-fact for the Corporation by virtue of her office.

The President shall, in the case of a tie vote of the Board of Directors, be able to cast one (1) additional vote in order to break the tie.

The President shall have the power to hire and supervise any and all staff that she deems necessary to help fulfill the vision of JOYCE FROHLICH MINISTRIES, INC.

The President or the Board reserves the right to exclude those persons from holding any position of leadership in JOYCE FROHLICH MINISTRIES, INC. or any of its related ministries, who have a life-style that is contrary to the Biblical standard set forth in our tenents of Belief as stated in ARTICLE THIRTEEN – STATEMENT OF FAITH of these By-Laws.

CONFLICT OF INTEREST:

Any director, officer, or key employee who has an interest in a contract, salary negotiation, or other transaction presented to the Board of Trustees or a committee thereof for authorization, approval, or ratification shall make a prompt and full disclosure of his interest to the Board of Trustees or committee prior to its acting on such contract or transaction. Such disclosure shall include any relevant and material facts known to such person about the contract or transaction which might reasonably be construed to be adverse to the corporation's interest.

The body to which such disclosure is made shall thereupon determine, by a vote of seventy-five (75%) of the votes entitled to vote, whether the disclosure shows that a conflict of interest exists or can reasonably be construed to exist. If a conflict is deemed to exist, such person shall not vote on, nor exert his personal influence regarding, nor participate in (other than to present factual information or to respond to questions) the discussions or deliberations with respect to such contract or transaction, such person may be counted in determining whether a quorum is present but may not be counted when the Board of Directors or a committee of the

Board takes action on the transaction. The minutes of the meeting shall reflect the disclosure made, the vote thereon, the abstention from voting and participation (where applicable), and whether a quorum was present.

THE HOLY SCRIPTURES We believe that the Holy Bible is the Word of God. It is the final authority of doctrinal truths. The Bible, in its original writing, is both inspired and inerrant (2 Timothy 3:16; 2 Peter 1:20-21; Proverb 30:5; Romans 16:25-26).

THE ETERNAL GODHEAD We believe that there is one God, who is a Trinity, or Tri-Unity, of three distinct persons: the Father, the Son, and the Holy Spirit. They are all co-equal and co-eternal (1 John 5:7; Gen. 1:26; Matthew 28:19;16-17; Luke 1:35; Isaiah 9:6; Hebrews 3:7-11).

FALL OF MAN We believe that man was created in the image of God but that by voluntary disobedience he fell from perfection (Genesis 1:26-31; 3:1-7; Romans 5:12-21).

JESUS CHRIST We believe that Jesus Christ is God the Son, the Second Person of the Trinity. Jesus Christ is 100% man and 100% God. He is the only man ever to have lived a sinless life (John 1:1,14; 20:28; 1 Timothy 3:16; Isaiah 9:6 Philippians 2:5-6; 1 Timothy 2:5).

VIRGIN BIRTH We believe Jesus Christ is the only-begotten Son of the Father, conceived by the Holy Spirit in the Firgin Mary. Therefore, Jesus is the Son of God (Matthew 1:18,20,33; Luke 1:27-35; Isaiah 7:14).

THE PLAN OF SALVATION We believe that while we were yet sinners Chirst died for us, (John 3:16, Romans 5:8). We believe that we are saved by grace through faith in Jesus Christ, His death, burial, and resurrection. Salvation is a free gift from God, not a result of our good works or of any human efforts (Ephesians 2:8,9; Galatians 2:16; 3:8; Titus 3:5; Romans 10:9-10; Acts 16:31; Hebrews 9:22).

CHRIST BLOOD We believe that because Jesus Christ lived a sinless life, His blood shed on the cross of Calvary is 100% sufficient to cleanse us of all sins when appropriated individually through repentance and faith. Jesus allowed himself to be punished for the sins we have committed, enabling all who believe to be freed from the penalty of sin, which is death (1 John 1:7; Revelation 1:5; Colosians 1:20; Romans 3:10;12,23;5:9; John 1:29).

REPENTANCE We believe repentance is a mommitment to turn away from sin in every area of our lives and to follow Christ. Through repentance we individually receive forgiveness of sins and appropriate salvation (Acts 2:38; 3:19).

THE NEW BIRTH We believe a Christian is a person who has invited the Lord Jesus Christ to come and live inside him by the Holy Spirit. He is putting his trust in what Christ accomplished for him when He died, was buried, and rose again from the dead (John 1:12; 14:17, 23; 15:4; Romans 8:11; Revelations 3:20).

WATER BAPTISM We believe that water baptism for the new convert is commanded by the Word of God to be baptized in water in the Name of the Father, and of the Son, and of the Holy Ghost (Matthew 28:19; Acts 2:38)

THE CHURCH We believe that the church is the Body of Christ, the habitation of God through the Spirit, with divine appointments for the fulfillment of Christ's great commission. Every person who is born of the Spirit is an integral part of the church as a member of the body of believers (Ephesians 1:22; 2:19-22; Hebrews 12:23).

THE LORD'S SUPPER We believe the Lord's Supper is a unique time of the communion in the presence of God when the elements of bread and grape juice, representing in some mysterious spiritual way the body and blood of the Lord Jesus Christ, are taken by believers in remembrance of Christ's sacrifice on the cross (1 Corinthians 10:16; 11:23-25; Mark 16:16; Acts 8:12; 8:26-38; 10:47-48; Matthew 26:26-28).

BAPTISM OF THE HOLY SPIRIT We believe the Baptism of the Holy Spirit is the promise of the Father, given by Jesus after His ascension, to empower the Church to preach the gospel throughout the whole earth and is evidenced by the speaking in tongues. The primary purpose of speaking in tongues is to bring edification to the believer by enhancing his prayer life (Acts 1:5, 8; 2:1-4, 17, 38-39; 8:14-17; 10:38, 44-47; 11:15-17; 19:1-6; Mark 16:17; Joel 2:28-29; Matthew 3:11).

SANCTIFICATION We believe sanctification is the ongoing process of being set apart for God, characterized by our yielding to God to complete the development of Christ's character in us. A lifestyle of developing righteousness and holiness is the evidence to all men that Christ's Spirit lives within us (1 Thessalonians 4:3; 2 Corinthians 3:18; 6:14-18; 2 Thessalonians 2:1-3; Romans 8:29; 12:1-2; Hebrews 2:11).

HEALTH AND PROSPERITY We believe that, as a part of Christ's work of salvation, it is the Father's will for believers to become whole, healthy and successful in all areas of life: Spiritual (John 3:3, 11; 2 Corinthians 5:17-21; Romans 10:9-10) Mental and Emotional (2 Timothy 1:7; Romans 12:2; Isaiah 26:3) Physical (Isaiah 53:4, 5; Matthew 8:17; 1 Peter 2:24)

Financial (Joshua 1:8; 3 John 2; Malachi 3:10-11; Luke 6:38; 2 Corinthians 9:6; Deuteronomy 38:1:14; Psalm 34:10; 84:11; Philippians 4:19).

HEALING OF THE SICK We believe that healing of the sick is illustrated in the life and ministry of Jesus, and is included in the commission of Jesus to His disciples. Healing is a provision of Christ's atonement on the cross, and is given as a sign which is to follow believers (Matthew 8:16-17; Acts 8:6-7; James 5: 14-16; 3 John 2; Psalm 103:2-3; Isaiah 53:5; Mark 16:17-18).

SECOND COMING We believe Jesus Christ will physically and visibly return to earth for the second time to establish His kingdom. This will occur at a time undisclosed by the Scriptures (Revelation 1:7; Acts 1:9-11; Matthew 24:30; 26:63-64; 1 Thessalonians 4:15, 17; 2 Thessalonians 1:7-8).

RESURRECTION We believe that Jesus Christ was physically resurrected from the dead in a glorified body three days after His death on the cross. One day all believers in Christ will also be physically resurrected in glorified bodies to their eternal reward in heaven with God (Luke 24:16, 36, 39; Philippians 1:21-23; 3:21; 1 Corinthians 15:42, 44; John 2:19-21; 20:26-28; 21:4; Acts 24:15).

HEAVEN We believe Heaven is the eternal dwelling place of all who believe in Jesus Christ (2 Corinthians 5:1; 1 Peter 1:4; Hebrews 11:16; John 17:24; John 17:24; Matthew 5:3, 12, 20; 6:20; 19:21; 25:34).

HELL We believe that after living one life on earth, those who have rejected Christ will be judged justly by God and sent to Hell, where they will be eternally tormented together with the devil and the fallen angels (Hebrews 9:27; Matthew 25:41; Revelation 14:9-11; 20:12-15; 21:8; Mark 9:43-48).

MARRIAGE We believe marriage is the uniting of one man and one woman in covenant commitment for a lifetime. It is God's unique gift to reveal the union between Christ and His church and to provide for the man and the woman in marriage the framework for intimate companionship, the channel of sexual expression according to biblical standards, and the means for procreation of the human race (Genesis 2:18-25; Proverbs 31:10-31; Malachi 2:14-16; Matthew 19:3-9; Ephesians 5:22-33; 6:1-4; 1 Thessalonians 2:7,11; 1 Timothy 3:1-12; 5:4; 1 Peter 3:1-7).
