Enclosed please find a Corporation Reinstatement form on behalf of our organization along with our check in the amount of \$61.25.

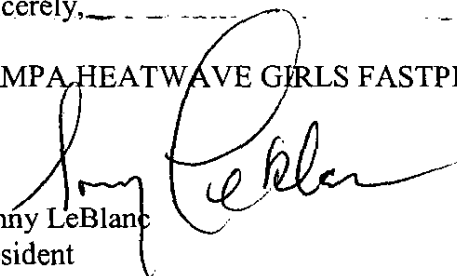
