If the registered agent is changed in the amendment, the new agent must sign accepting the appointment and must state that he or she is familiar with and accepts the obligations of the position.

The filing fee for the articles of amendment is \$35. Certified copies of the amendment are \$52.50 each. Submit one check for the correct amount made payable to the Department of State. Please include a cover letter containing your telephone number and return address.
