**ARTICLES OF AMENDMENT
OF
UNIVERSITY PARK COMMUNITY ASSOCIATION, INC.**

Pursuant to Section 617.1006, Florida Statutes, the Articles of Incorporation of University Park Community Association, Inc., a Florida corporation not for profit (the "Association"), formed on July 31, 1991, and assigned document number N44504, are hereby amended as follows:

1. The last sentence in Article 6.4 is hereby stricken in its entirety.
2. The last sentence in Article 7.1 is hereby stricken in its entirety.

The amendments were adopted by resolution of the directors of the Association on October 25, 2019. Pursuant to Article 10 of the Articles of Incorporation, no members of the Association were entitled to vote on the amendments.

In witness whereof, the President of the Association has executed these Articles of Amendment as of the 25th day of October 2019.




