Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER (S) BEING AMENDED, ADDED OR DELETED.)

Preamble shall be changed to read:

WE, the undersigned persons, competent to contract, do hereby make, subscribe, acknowledge and file these Articles of Incorporation for River City Family Church, Inc., a non-profit FLORIDA corporation; and we respectfully request the Secretary of State to approve this incorporation under the following proposed Articles of Incorporation:

ARTICLE I: The name of this non-profit corporation is River City Family Church, Inc.

ARTICLE IV: STATEMENT OF FAITH: We affirm the Holy Bible as the inspired, infallible Word of God, and as the only basis of our beliefs. RCFC accepts "The Baptist Faith and Message," a 1963 affirmation of basic Christian beliefs, as a general statement of our faith.

ARTICLE VII: Replace WRCBC with RCFC.

SECOND: The date of the adoption of the amendments was November 28, 2001.
