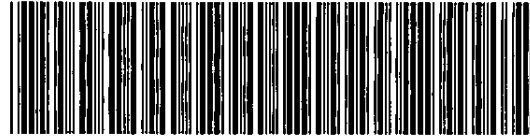

### **STATEMENT OF DISTINCTIVES**

MORE THAN CONQUERORS MINISTRIES INC. of Coral Springs, Florida is a non-denominational independent church that is in fellowship with Faith Fellowship Ministries in Sayreville, New Jersey. We are an independent body of believers with the following distinctive:

1. We hold to:
  - a. The Inerrancy of Scriptures
  - b. The continuance today of the diversities of Spiritual gifts as found in Romans 12, 1 Corinthians 12:4-11, and Ephesians 4.
  - c. The simplicity of church government, rather than a complex bureaucracy.
  - d. The dependence on the Holy Spirit to lead us rather than fleshly promotion.
  - e. The pre-millennial, pre-tribulational return of Christ for his waiting Church.
  - f. The systematic approach to the study of the Word of God that emphasizes application in our daily lives.
2. Marriage and Human Sexuality:
  - a. Marriage is biblical institution establish by God as clearly described in the scriptures. This Church recognizes that marriage is the uniting of one man and one woman in covenant commitment for a lifetime. Accordingly, this Church, its pastors, staff and members will not participate in same sex unions or same sex marriages, nor shall its property or resources be used for such purposes.
  - b. Human Sexuality – The Bible teaches that legitimate sexual relations are exercised solely within marriage. Hence, this Church opposes all forms of sexual immorality, including adultery, homosexuality, and pornography.
3. We Reject:

  - d. New age doctrine and any other cult or religion that does not adhere to our statement of faith as found in the By-Laws of our Church
