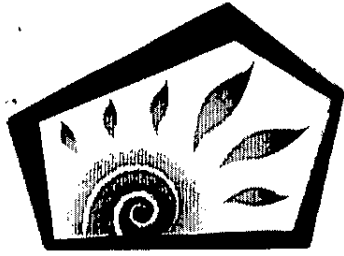

**RESTATED  
ARTICLES OF INCORPORATION  
OF THE  
SUNCOAST WALDORF ASSOCIATION, INC.**

**ARTICLE I**

*Name*

The name of this corporation shall be the Suncoast Waldorf Association, Inc., hereafter referred to as "the Corporation".

**ARTICLE II**

*Purpose*

1. The purpose for which the Corporation is organized is exclusively educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
2. The specific purpose and objects of the Corporation shall be to establish and operate a school which shall serve children in preschool and kindergarten through grade 12 with the curriculum subscribed to by Waldorf schools worldwide and to establish and provide Waldorf educational and training programs for parents and teachers.
3. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. All activities of the Corporation shall be open to individuals without regard to race, color, gender, religious affiliation or beliefs, sexual orientation, age, national origin or physical impairment.
4. The attainment of profit shall not be a purpose of this Corporation.

**ARTICLE III**

*Use Of Income*

All revenue received from the conduct of such business or enterprise of the Corporation is to be used and employed in the provision of educational services as set forth in Article II above and shall not be for the benefit of the members of the Corporation, either individually or collectively.

**ARTICLE IV**

*Powers*

The Corporation shall have the power to do all things necessary or expedient to carry out the purpose of the Corporation and, in general, to possess all of the rights, privileges, immunities and all of the benefits granted to corporations of a similar character that are organized under the Laws of the State of Florida, including, but not limited to, the power to acquire, either by gift or purchase, and to encumber, in any manner, lease and improve, all real estate and personal

property owned by the Corporation for the purpose of promoting the general purposes and objects of the Corporation as expressed in Article II of these Articles of Incorporation.

## ARTICLE V

### *Term Of Existence*

This Corporation shall have perpetual existence.

## ARTICLE VI

## ARTICLE VII

### *Board Of Trustees*

The affairs of the Corporation shall be managed by a Board of Trustees, subject to and in accordance with the Bylaws and the laws of the State of Florida. The Trustees shall be appointed as provided in the Bylaws of the Corporation.

## **ARTICLE VIII**

### *Bylaws*

The Board of Trustees shall have the right to make and adopt such bylaws as it deems proper.

## **ARTICLE IX**

### *Amendments To Articles Of Incorporation*

These Articles of Incorporation may be amended by Board of Trustees of the Corporation as provided in the Bylaws.

## **ARTICLE X**

### *Dissolution; Transfer Of Assets*

Should this Corporation cease to function and the Board of Trustees has adopted a Resolution to dissolve the Corporation, then the Board of Trustees shall distribute the assets thereof, after all encumbrances have been removed, for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall distribute them to the Federal government, or to a state or local government purpose. Any net assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

## **ARTICLE XI**

### *Registered Agent*

The current registered agent for this Corporation is Barbara Bedingfield, and the current registered office is located at 1857 Curlew Road, Palm Harbor, Florida 34683.

## **ARTICLE XII**

### *Adoption Of Restated Articles*

These Restated Articles of Incorporation, including all amendments thereto have been adopted by resolution of the Board of Trustees at a meeting held in accordance with Florida Statutes, Section 617.1002, 617.1006, and 617.1007. Member approval was not required.
