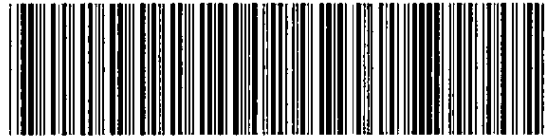

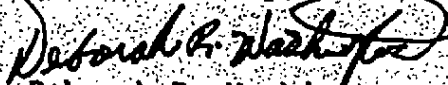

We, the undersigned, hereby associate ourself together for the purpose of becoming a corporation not for profit under Chapter 617, Laws of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation not for profit, adopt the following Articles of Incorporation of such corporation:

ARTICLE I

NAME OF CORPORATION

ARTICLE II

DURATION OF CORPORATION

The period of duration of this corporation is, Perpetual.

ARTICLE III

GENERAL NATURE OF BUSINESS

The purpose (purposes) for which the corporation is organized is as follows:

- A. This Corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation is: To cultivate, promote and extend the teachings and practices of Jesus Christ, our Lord and Savior.
- B. To preach, teach and establish churches in the Apolistic Order, to ordain Bishops, Elders, Deacons and Women to preach the Gospel according to the call of God, and to perform ceremonies.

- D. To exercise all rights and powers conferred by the laws of the State of Florida upon non-profit corporations.

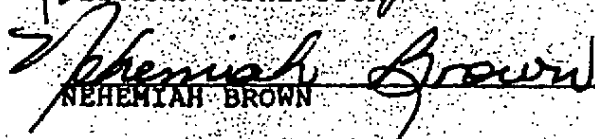

ANY SUCH ASSETS NOT SO DISPOSED OF BY THE COURT OF COMMON PLEAS OF THE COUNTY IN WHICH THE PRINCIPAL OFFICE OF THE CORPORATION IS THEN LOCATED, EXCLUSIVELY FOR SUCH PURPOSES OR TO SUCH ORGANIZATION OR ORGANIZATIONS, AS SAID COURT SHALL DETERMINE, WHICH ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
