

### Article 12

Said Organization is organized exclusively for religious, educational, charitable, and scientific purposes, lincluding for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code

### Article 13

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be aurthorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of proganda, or otherwise attempting to influence legislation, and the organizationshall not participate on intervenein (including the publishing or distribution of statements) and any political campaign on the behalf of any candidate for public office. Not withstanding anyother provision of this document, the organization shall not carry on any other activities not permitted to be on (a) by an organization exempt from federal income tax under the section 501(c) (3) of the Internal Revenue Code, or corresponding section 170 (c) (2) of the Internal Revenue Code or corresponding section of any future federal tax code.

### Article 14

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the County in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine which are organized and operated exclusively for such purposes
