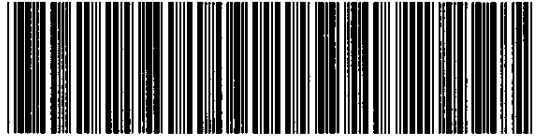

churches are found."

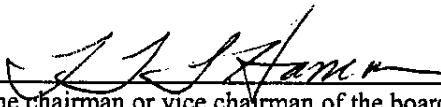
