Pursuant to the provisions of Section 617.1403 of the Florida Statutes, the undersigned Florida corporation not for profit hereby adopts the following Articles of Dissolution:

ARTICLE I - NAME OF CORPORATION

The name of the corporation is Private Railroad Crossing Paint Street Owners Association, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - DATE DISSOLUTION AUTHORIZED

The dissolution of the Corporation was authorized on December 14, 2001.

ARTICLE III - APPROVAL OF DISSOLUTION

The resolution to dissolve the Corporation was unanimously adopted and approved by all of the members of the Corporation by written consent dated December 14, 2001, executed in accordance with the provisions of Section 617.0701 of the Florida Statutes.

ARTICLE IV - EFFECTIVE DATE OF DISSOLUTION

The Corporation shall be dissolved effective upon the filing of these Articles of Dissolution with the Secretary of State of the State of Florida.
