## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SOUTH FLORIDA GUARDIANSHIP PROGRAM, INC.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the Articles of Incorporation of SOUTH FLORIDA GUARDIANSHIP PROGRAM, INC. (the "Corporation"), Document Number N45592, are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is SOUTH FLORIDA GUARDIANSHIP PROGRAM, INC.

SECOND: Article IX, Initial Directors and Officers of the Articles of Incorporation are hereby amended to read as follows:

## ARTICLE IX

This Corporation shall have three directors initially. The number of directors may be increased or diminished from time to time as permitted by the By-Laws, but shall never be less than three (3). The method of election of directors is as set forth in the By-Laws. The name and addresses of the Directors of this corporation are:

THIRD: The Corporation has no members. The foregoing amendments were adopted unanimously by the Board of Directors on May 21, 2012.

FOURTH: Except as hereby amended, the existing Articles of Incorporation of the Corporation shall remain in full force and effect.
