ARTICLES OF AMENDMENT  
TO THE

The Central Park Village Resident Management Corporation (herein called the "Corporation") filed its original Articles of Incorporation on November 6, 1991. The Articles of Incorporation were later amended and the Amended Articles of Incorporation were filed on August 28, 1992.

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the Corporation adopts these Articles of Amendment to its Articles of Incorporation.

1. Article Five is amended to read as follows:

**ARTICLE FIVE**

**DIRECTORS**

The number of directors constituting the Board of Directors shall be set forth in the Bylaws, but shall be no fewer than five (5) and no more than nine (9).

2. Article Eight is amended to read as follows:

**ARTICLE EIGHT**

**ELECTION OF OFFICERS**

The officers shall be selected in the manner set forth in the Bylaws.

3. The date of adoption of these Articles of Amendment was January 23, 1998.
4. The members of the Corporation are not entitled to vote on these amendments. These Articles of Amendment were adopted by the Corporation's Board of Directors.
