The two presiding officers on the Executive Council/Board of Directors are Fred McMillion who is the President of the Board of the Directors (PBD) controlling theological policy and operations. He is therefore also a voting Director. The other presiding is John A. McMillion, Vice President of the Board of Directors and Overseer. This title was abbreviated as VOD. The Overseer has authority to run the day to day operations of the corporation and presides over the board in the absence of the president.
