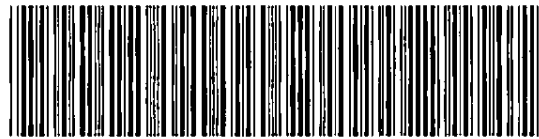

AMENDING: ARTICLE III PURPOSE

The organization is organized exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The not for profit corporation is organized to provide a charitable emergency response for fire and rescue services, promote fire safety through literature and training to protect life and property of all residents of Concord, Havana, and Gadsden County, Florida.

ADD: ARTICLE III (a) TAX STATUS

Said corporation is organized under the Florida Not for Profit Corporation Act in compliance with Chapter 617, Florida Statutes. The organization shall be operated under the laws of Florida and Gadsden County and in Compliance with section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ADD: ARTICLE III (b) EARNINGS

No part of the net earnings of the corporations shall inure to the benefit of, or be distributable to its members, trustees, officers, or private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempt to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.


