To Whom It May Concern,


The H. B. Plant High School Chorus Boosters Club, Inc. received notification that the Florida Department of State had dissolved its corporation for failure to file its 1998 Annual Report Form as required by law. Actually, the report was filed as required, but was not processed due to an oversight on our part.

Upon receipt of the notice of dissolution, I contacted the Florida Department of State for an explanation. I was informed that our annual report had not been processed because we had failed to designate the minimum of three (3) "Directors" required for a Florida Nonprofit Corporation. I was also informed that the report had been returned to us to be corrected and re-submitted. We never received the report and therefore were not aware that our status as a nonprofit corporation was in jeopardy.

The instructions given to me by your representative were to complete the Application for Reinstatement, and return it with the Annual Report Fee and a letter of explanation. I have also included a copy from our files of the annual report that was originally submitted.
