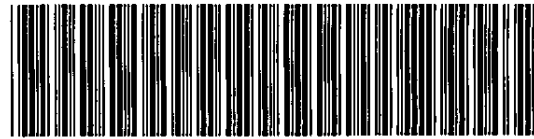

amending Amending ARTICLE II - PURPOSE is hereby amended to read as follows:

Article II

Purpose

The purposes for which the Association is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. In addition, this Association is organized to promote the development and economic revitalization of communities in Palm Beach County, the State of Florida and on a national program undertaking.

Notwithstanding any other provision of these articles, this Association shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

The Association shall make no distribution of income to its members, directors or officers.
