I, JOHN LESTER, the undersigned incorporator, for the purpose of forming a nonprofit Corporation under and by virtue of the laws of the State of Florida, certify that the following are the Amended and Restated Articles of Incorporation of Tampa Bay Survey and Mapping Scholarship Fund, Inc.

ARTICLE I

NAME, DURATION, REGISTERED OFFICE AND AGENT

- (a) The name of the Corporation is TAMPA BAY SURVEY AND MAPPING SCHOLARSHIP FUND, INC., also doing business as TBSMSF Inc., hereinafter referred to as "the Corporation."
- (b) The existence of the Corporation will be perpetual.
- (c) The initial registered office of the Corporation will be located at 3118 Kensington Avenue, Tampa, Florida 33629.
- (d) The initial registered agent of the Corporation is John Lester whose address is 3118 Kensington Avenue, Tampa, Florida 33629 and whose mailing address is 3118 Kensington Avenue, Tampa, Florida 33629.

ARTICLE II

PURPOSE

- (a) The purpose of the following is to further education in the field of land surveying and mapping, and to provide assistance to future land surveyors to obtain degrees in land surveying and mapping, and in general to provide scholarship aide in the form of

grants, loans, and gifts, in accordance with the availability of funds for such purposes.

The Fund may pay all or part of the tuition, or other fees for courses in land surveying and mapping at a Florida university or other educational institution primarily for, but not limited to, students in the Tampa Bay area. The Fund shall raise money through gifts and donations, as well as other means to furnish all necessary funding.

Scholarships, grants and loans shall be available to applicants without regard to sex, race, religion, or national origin or other forms of discrimination prohibited by local ordinance.

- (b) The Corporation is irrevocably dedicated to and operated exclusively for, nonprofit purposes; and no part of the income or assets of the Corporation shall be distributed to, nor inure to the benefit of, any individual.

ARTICLE III

POWERS

The Corporation is empowered:

- (a) To do all lawful things necessary to carry out the purposes stated in Article II.
- (b) To have all the corporate powers enumerated in the Florida Not For Profit

Corporation Act not inconsistent with these articles and appropriate for not for profit corporations.

ARTICLE IV

DIRECTORS

- (a) The Board shall be comprised of seven (7) members.
- (b) Two (2) Directors shall be appointed by the President of the West Coast Land Surveyors Association. One of these Directors will be designated as the Board's Arbitrator by said President.
- (c) Two (2) Directors shall be appointed by the President of the Tampa Bay Chapter of the Florida Surveying and Mapping Society.
- (d) At the first meeting, from and by the Directors, a Chairperson will be elected. Should a tie vote occur, the selection of the Chairperson will be at the sole discretion of the Board's Arbitrator.
- (e) The Chairperson will appoint the final three Directors to the Board.
- (f) The Board of Directors will elect a Vice-Chairperson, a Secretary and a Treasurer.
- (g) These Directors shall hold office for such terms as may be specified in the By-Laws.

All directors shall serve without compensation for their services. The original directors, and the term for which each will serve, are set forth below:

Members of the Board of Directors may participate in special meetings of the Board of Directors by means of conference telephone as provided by law, but annual meetings of the Board of Directors must be attended in fact in person by each Director.

The Directors of this Corporation may take action by written consent, as provided by law.

ARTICLE V

MEMBERSHIP

The membership of this Corporation shall constitute all persons named as Directors and such other persons as from time to time hereafter may become members in the manner prescribed in the By-Laws.

ARTICLE VI

OFFICERS

The Officers of the Corporation, as provided by the By-Laws of the Corporation, shall be elected by the Directors of the Corporation, in the manner therein set out, and shall serve until their successors are elected to have qualified. The affairs of the Corporation shall be managed by the Chairman, Vice Chairman, Secretary and Treasurer. The initial officers are Chairman – Leslie Pierce, Vice Chairman – Dan Sullivan, Treasurer – John Lester, and Secretary – Jennifer Swanson, who shall serve until the first meeting of the Board of Directors, at which meeting the Officers for a one year term shall be elected. The Directors shall elect the regular Officers of the Corporation at the annual meeting, for terms of one year.

The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

ARTICLE VII

BY-LAWS

By-Laws of the Corporation may be adopted, altered or rescinded by the Directors at any regular meeting or any special meeting called for that purpose, so long as they are not inconsistent with the provisions of these Articles.

ARTICLE VIII

AMENDMENT

The Corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation, or any amendment to them, so long as appropriate for a nonprofit tax exempt corporation. These Articles of Incorporation may be amended at a

general or special meeting of the board of directors called for that purpose by a majority vote of those present.

ARTICLE IX

DISSOLUTION

In the event of dissolution of the Corporation, the residual assets of the Corporation will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501 (c) (3) and 170 (c) (2) of the Internal Revenue Code of 1954 or corresponding Sections of any prior or future law, or to the Federal State or local government for exclusive public purposes.

ARTICLE X

PROHIBITED ACTIVITIES

Notwithstanding any other provision of these Articles, the Corporation will not carry on any other activities not permitted to be carried on by (a) a corporation exempt from Federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provision of any future United States internal revenue law or (b) a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 or any other corresponding provision of any future United States internal revenue laws.
