The corporation shall provide safe housing an or facilities for persons in need and distressed.

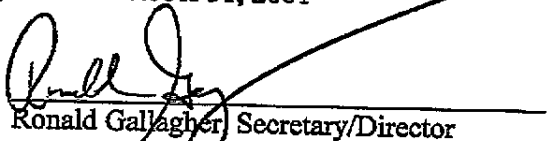
