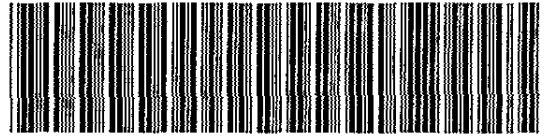

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted:

AMEND "FIRST"

TO READ: This is to certify that we, Kevin Sas, Al Woods, Mark Hemler, Steve Dieter, Jill Sas, all being of legal age, do, under and by virtue of the laws of the State of Florida, associate ourselves with the intention of forming a non-profit corporation to provide recreational, social, and cultural activities to children residing in the Metro Orlando area, in Orange County, Florida.

AMEND "SECOND"

TO READ: The purpose for which this corporation is formed and the primary object to be carried on by it is to promote, support, plan, and sponsor recreational and sporting activities for children aged five through eighteen. No child shall be denied participation in any activity of this corporation by virtue of race, religion, or national origin.

AMEND "FOURTH"

TO READ: The Officers/Directors of this corporation shall be **President, Vice-President, Treasurer, Safety Officer, Player Agent, and Secretary**, and they shall be elected each May as provided in the By-Laws. The Officers/Directors named above shall serve until 15 January 1993, or until their successors are qualified and elected.
