

RESTATED ARTICLES OF INCORPORATION OF THE MANUFACTURERS ASSOCIATION OF CENTRAL FLORIDA, INC.

ARTICLE I

NAME

The name of this corporation shall be The Manufacturers Association of Central Florida Inc. (hereinafter the "Corporation").

ARTICLE II

PRINCIPAL OFFICE

The street address of the principal office of the Corporation shall be 301 E. Pine Street, Suite 900, Orlando, FL 32801.

ARTICLE III

PURPOSES

The purpose of the Corporation is to generally promote the business interests of the manufacturing industry as a business league as provided in 28 USCA § 501(c)(6), and the applicable Rules and Regulations thereunder, together with all other activities permitted by Chapter 617, Florida Statutes, the Florida Not-for-Profit Corporation Act, which further the Corporation's exempt purposes, including, but not limited to, uniting individuals and any others engaged in the manufacturing industry within Central Florida to promote, advance and protect the mutual interests of the Corporation's members and the industry at large, to provide a forum for sharing of solutions and knowledge gained by its members in Central Florida, to promote manufacturing interests and careers to schools, legislators, the public and otherwise, and in general to promote and advance the image and identity of the manufacturing industry in Central Florida.

The Corporation is a not-for-profit corporation under Chapter 617, Florida Statutes. The Corporation is not formed for pecuniary profit. No part of the income or assets of the Corporation is attributable to or for the benefit of its directors or officers, except to the extent permissible under these Articles, under law and under 26 USCA § 501(c)(6). No member of the Corporation shall have any vested right, interest or privilege in or to the assets, income or property of the Corporation, and no part of the income or assets of the Corporation shall be distributable to or for the benefit of its members, except to the extent permissible under these Articles, under law and under 28 USCA § 501(c)(6). No part of the net earnings, properties or assets of the Corporation, upon dissolution or otherwise, shall inure to the benefit of any private person, or individual, or any member or director of the Corporation.

ARTICLE IV

MANNER OF ELECTION OF DIRECTORS

The manner in which the directors of the Corporation are and will be elected or appointed will be as set forth in the By-laws of the Corporation, as amended from time to time.

ARTICLE V
