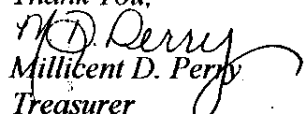

Recently it was brought to my attention, as the current club treasurer, that our status with the state is presently inactive. As a social club with directors, as voted in annually, officers change and the club records change hands frequently. As to who were the officers at the time of dissolution, I am unaware. However, at a meeting of the current board of directors last night, the matter of the club's inactive status was discussed. Present were most all officers, including the designated registered agent for the club, Stephen Bullock. Mr. Bullock is also the one who did the last reinstatement which was filed January 29, 2001. He recalled that he had reinstated the status at that time for the same reason I am now, simply because a particular matter at hand brought it to his attention that the corporate status was inactive. He also questioned where the annual reports had been going, as they had not been received. The address on the last reinstatement was discussed with the directors, of which not one was familiar with it. It was concluded that the dissolution was in fact a result of non receipt of the annual report. It was further concluded that had the annual report been received, it would have been presented at the next monthly meeting to the treasure at that time for completion and submission to the state. All issues are presented to the directors at monthly meetings and the club makes every effort to keep accurate records. However, as the records do change hands when a new treasurer is designated and not all treasurers are familiar with state filing requirements, past treasures were unaware of the club's inactive status. Had annual reports been received this would have alerted them of the matter that needed to be addressed.

Our request at this time is to simply have the reinstatement fee waived on our reinstatement in lieu of the fact that annual reports have not been received by the club.

The enclosed reinstatement reflects a current and correct mailing address for all future reports.
