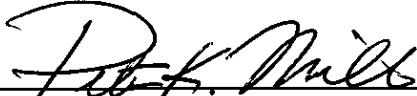

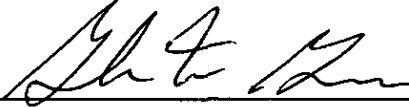
WHEREAS, Robert R. Bachmann, agrees to accept the appointment;

NOW THEREFORE, BE IT RESOLVED that

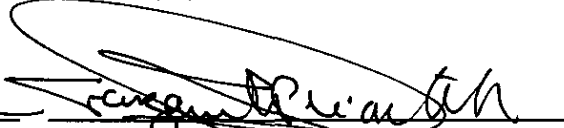

- 2. Resignation of this appointment by Robert R. Bachmann, if any, shall be made by mailing a statement to the residence address of the President of the Association.**

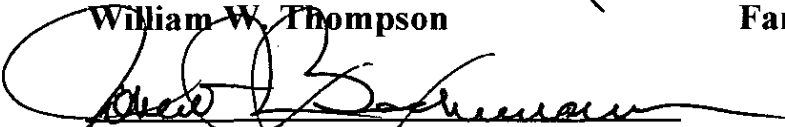
