

### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF MARINA PALMS HOMEOWNERS ASSOCIATION, INC.

1. Adopted amendment to ARTICLE I, Section 1.0 of the Articles of Incorporation of Marina Palms Homeowners Association, Inc. (the "Articles"), to read as follows:

#### ARTICLE I

1.0 Corporate Name: The corporation's name is MARINA PALMS HOMEOWNERS ASSOCIATION, INC., and may be referred to herein as the "Association."

Turnover of control of the Association occurred many years ago, and the rights and obligations of Developer expired at that time. 
