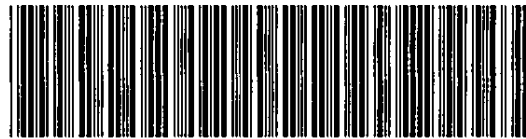

**AMENDED AND RESTATED ARTICLES OF INCORPORATION  
OF  
GOOD NEWS CHURCH OF OCALA, INC.**

The undersigned, as Secretary of Good News Church of Ocala, Inc., does hereby certify that:

The original Articles of Incorporation of the Corporation were filed on February 21, 1992 with the Florida Secretary of State; and

On September 2, 2012, the Board of Directors of the Corporation, pursuant to Article 9 of the Corporation's original Articles of Incorporation and Florida State Statute 617.1007, voted to amend and restate the Articles of Incorporation by a majority vote of the Board of Directors.

NOW, THEREFORE, it is resolved, that the Articles of Incorporation are hereby amended and restated in their entirety as follows:

**ARTICLE I**

The name of the corporation shall be Good News Church of Ocala, Inc.

**ARTICLE II**

The street address and mailing address for the principal office of the Corporation is  
5600 SE 24<sup>th</sup> Street, Ocala, FL 34480

**ARTICLE III**

The Corporation shall have perpetual existence.

**ARTICLE IV**

**Section 1:** The purpose of the church is to be a resource for people to meet Jesus and become members of His family, for encouragement for their Christ-like maturity, for equipping them to magnify God and to accomplish their personal ministry in the church and life mission in the world. We exist to bring glory to God through lives changed by the gospel of Jesus Christ. We will: Love God, love each other, and love people who don't know God yet.

**Section 2:** The Corporation is organized as a nonprofit church and is operated exclusively for religious, charitable, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code). No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, pastors, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance

of the religious, charitable, and educational purposes of the church. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or the corresponding section of any future federal tax code).

#### **ARTICLE V**

Upon dissolution of the Corporation, the assets remaining after payment or provisions for the payment of all debts and liabilities of the Corporation shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future federal tax code) or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes. Such distribution shall be made in accordance with the applicable provisions of the laws of this state.

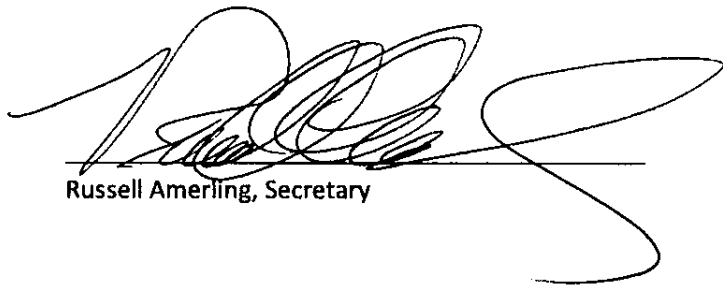

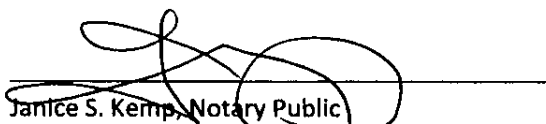
