### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF



## HEALTHY START COALITION OF HILLSBOROUGH COUNTY, INC.

#### THIS IS TO CERTIFY THAT:

FIRST: These Articles of Amendment amends the Articles of Incorporation of Healthy Start Coalition of Hillsborough County, Inc., a Florida nonprofit corporation ("Corporation").

SECOND: The Articles of Incorporation of the Corporation were filed with the Florida Department of State on February 27, 1992, and the document number of the Corporation is N47615.

THIRD: Article XII of the Corporation's Articles of Incorporation is hereby amended by deleting the existing Article XII and replacing it with the following:

"The address of the Corporation's principal office shall be 2806 North Armenia Avenue, Suite 100, Tampa, Florida 33607; and the name of the Registered Agent is Jane Murphy, whose address is 2806 North Armenia Avenue, Suite 100, Tampa, Florida 33607 until changed by a required filing with the State of Florida."

FOURTH: Article XIII of the Corporation's Articles of Incorporation is hereby amended by deleting the existing Article XIII and replacing it with the following:

The Principal Office of the Corporation shall be located at the 2806 N. Armenia Avenue, Suite 100, Tampa, Florida 33607 until otherwise changed by the Board of Directors, and the mailing address is the same as the Principal Office.

FIFTH: The date of adoption of these Articles of Amendment is June 2, 2021.

SIXTH: These Articles of Amendment were adopted by Resolution by the Board of Directors, by a majority vote of the membership of the Corporation. The number of votes cast for this amendment by the members was sufficient for approval.
