Amended and Restated Articles of Incorporation of Sea Gate Elementary School Parent-Teacher Organization, Inc.

The name of the not-for-profit corporation is Sea Gate Elementary School Parent-Teacher Organization, Inc. (the "Corporation"). The Corporation's original Articles of Incorporation (the "Original Articles") were filed with the Florida Department of State on February 27, 1992 and assigned document number N47667. These Amended and Restated Articles of Incorporation (the "Amended and Restated Articles") contain amendments and restatements to the Original Articles and do not require member approval. A majority of the Board of Trustees of the Corporation adopted and approved these Amended and Restated Articles on April 10, 2018.

These Amended and Restated Articles shall become effective upon filing with the Florida Department of State. Upon filing, the Original Articles shall be superseded and these Amended and Restated Articles shall be the articles of incorporation of the Corporation.

The Corporation hereby restates and integrates and also further amends its Original Articles as follows:

Article I The name of the corporation is <u>Sea Gate Elementary School Parent-Teacher</u>
Organization, Inc.

Article II The principal place of business and mailing address of this corporation is: 650 Sea Gate Drive, Naples, Collier County, Florida 34103.

Article III The purposes for which this Corporation is formed are:

a. The Corporation is organized for exclusively religious, charitable, educational and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law, including, for such purposes, the making of distributions to organizations that qualify as exempt under said Section 501(c)(3) of the Internal Revenue Code of 1986.

- b. Notwithstanding any other provision of these Articles, this Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or any corresponding provision of any future United States Internal Revenue Law.
- c. No part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in

(including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

Article IV The board of directors of the Corporation shall be elected or appointed in the

manner and for the terms provided in the Corporation's Bylaws.

Article VI The address of the initial registered office of the Corporation is:

Article VIII No part of the net earnings of the Corporation shall inure to the benefit of any officer or director of the Corporation; and upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the Corporation, dispose of the residual assets of the Corporation exclusively for the exempt purposes of the Corporation in such manner, or to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future United States Internal Revenue Law. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the Corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and
