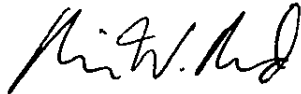

Pursuant to Chapter 617, Florida Statutes, the Articles of Incorporation of the above named corporation are hereby amended as follows:

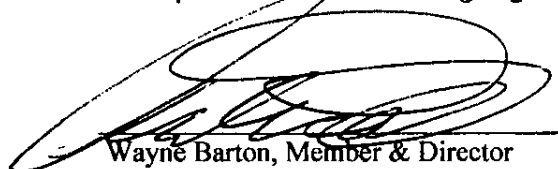
1. Article (a) is amended to read as follows:

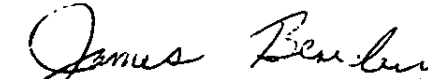
(a) Name. The name of this corporation shall be: Wayne Barton Study Center, Inc.
