

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CULTURAL ARTS ASSOCIATION OF WALTON COUNTY, INC. A NON-PROFIT FLORIDA CORPORATION

Pursuant to the provision of section 617.1006, Florida Statutes, this Florida Not for Profit Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: <u>NEW CORPORATE NAME</u>:

Cultural Arts Alliance of Walton County, Inc.

SECOND: Amendments adopted:

ARTICLE X

BY-LAW AMENDMENT

The power to adopt, alter, amend or repeal the by-laws of this corporation shall be vested in the Board of Directors of this corporation.

ARTICLE XI

MEMBERSHIP

Membership shall be by application to and approval of the Board of Directors of this corporation. The Board of Directors of this corporation shall, in its discretion, determine and set categories of membership, terms and dues of membership. No class, category, nor individual members shall have voting rights.

ARTICLE XIII

DIRECTOR QUORUM AND VOTING

Forty percent (40%) of the Directors of the corporation shall constitute a quorum for a meeting of the Board of Directors of this corporation. If a quorum is present, the affirmative vote of a majority of the Directors present or, if a Director or Directors have abstained from voting for cause, the affirmative vote of a majority of the Directors present and voting shall be the act of the Board of Directors. Not withstanding the forgoing provisions, in order to amend, alter, repeal or revise the bylaws of the corporation, the affirmative vote of two-thirds of the Directors present or, if a Director or

Directors have abstained from voting for cause, the affirmative vote of two-thirds of the Directors present shall be the act of the Board of Directors.

ARTICLE XVI

MEETING BY CONFERENCE TELEPHONE

Directors of this corporation may participate in special and regular meetings of the Board of Directors of the corporation by means of conference telephone or web based audio video conference communication equipment provided that all Directors participating in any such meetings can hear one another.
