Article VI Section 3: Delete first full sentence of said Section 3 (to eliminate term limits for Trustees)

Article XII Section 3: Delete entire contents of Section 3 and replace it with the following:

ARTICLE XII

Section 3. The annual amount of scholarships awarded shall be determined by the Board of Trustees so long as the amounts awarded do not disqualify the Foundations status as a 501(c)(3) or public charity.

The remainder of Article VI, Article XII, and all other Articles are hereby ratified and not amended.
