## CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PALM GROVE ASSOCIATION, INC. AMENDED AND RESTATED NOVEMBER 1, 2002

SECRETALLAMASSES, FL

The Articles of Incorporation for Palm Grove Association, Inc. were Amended and Restated on November 1, 2022 and recorded in the public records of St. Lucie County, Florida on November 25, 2002, at Official Records Book 1617, Page 2580 et. seq. The same Articles of Incorporation were amended as approved by the membership by vote sufficient for approval at the meeting of the members.

1. Article IX is amended to read as follows:

## **ARTICLE IX: AMENDMENTS**

- 1. Amendments to these Articles, the Declaration, the By-Laws, the Rules and Regulations, and the Architectural Control Rules, must be approved by a majority vote of:
  - (a) The Board of Directors; and
- (b) The total votes cast by the members entitled to vote at a membership meeting at which a quorum is present. The Board of Directors need not vote at the same time as the membership.
- 2. Amendments may be proposed by the Board of Directors or by a majority vote of the membership at a meeting when thirty (30) percent or more of the total voting interests are present in person or by proxy.
- 2. The foregoing amendment to the Articles of Incorporation were adopted by the membership by a vote sufficient for approval at a meeting of the membership.
- 3. The adoption of this amendment appears upon the minutes of said meeting and is unrevoked.
- 4. All provisions of the Articles of Incorporation are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
