Article I Name: The name of this corporation shall be Bible Teachers International Palm Beach-

Agape Christian Temple, Incorporated.

Article II Purpose, B. change to: In furtherance, but not in limitation, of the foregoing religious, scientific, charitable and educational purposes, the corporation shall have the following powers:

Articles II Purpose, B5 third line add ministerial development, after the words "developing their capabilities" paragraph continues as written after that.

Articles II Purpose, B8 add, "including those specifically enumerated in Chap 617, of the Florida Revised Statutes, (Nonprofit Corporation Law)

Articles III, Members, Section 2. Manner of Admission: delete last sentence: Membership shall be conferred upon the applicant by a simple majority of the votes cast by the congregation.

**Add Section 3. Membership:**

- A. This corporation shall not have members, shareholders, or capital stock.
- B. No trustee, director, officer or other individual shall at any time have any interest in the earnings or income of the corporation, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the corporation and to make payments and distributions in furtherance of the purposes set forth in Article II B.8 and C thereof.

Article VI Board of Directors, Section 1 General Powers: **delete existing and add:** The management and regulation of Bible Teachers International Palm Beach- Agape Christian Temple Inc., shall be governed by a board of directors and such officers as may be appointed by said directors in accordance with Articles of Incorporation and By-Laws of this corporation.

Article VI Board of Directors, Section 2, Numbers and Qualification, B. Board: **change the last sentence to read:** The Board of Directors shall never be fewer than three (3) and no more than twelve (12). The exact number shall be determined at the discretion of the existing directors.

Article VI Board of Directors, Section 2, Number and Qualification B Board: **Add: C.** The Board of Directors shall include the officers of the corporation.

Article VI Board of Directors, Add Section 6. Compensation:  
Reasonable compensation for director and officers shall be set at the discretion of the Board of Directors.

Article VII, Officers, Section 3, Add, the letter A. before explanation (The officers...)

Article VII, Officers, Section 3, Add: B. The officers of the corporation are ex officio voting member of the Board of Directors.

Article VII, Officers, ADD: Section 4 Liability of Directors and Officers  
Any officer or director of the corporation shall not be liable for any monetary damages to the corporation for any breach of fiduciary duty. The corporation shall indemnify all officers and directors for all acts performed during or as a result of their duties for and on behalf of the corporation provided that such indemnification shall not conflict with the laws of the State of Florida.

**Article XI Dissolution, delete entire section and change to:**

A. The Board of Directors may, by unanimous vote, cease corporate activities and surrender the corporate franchise.

B. In the event of dissolution of the Corporation or the winding up of its affairs, the distribution of corporate assets shall be decided by majority vote of the Board of Directors under the outlined provisions.

1. The residual assets of the corporation shall be turned over to one or more Organizations which themselves are exempts as organizations described in Sections 501 (c) (3) and 270 (c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code.
