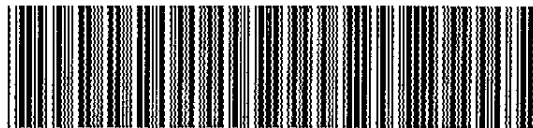

This letter pertains to our recent conversation.

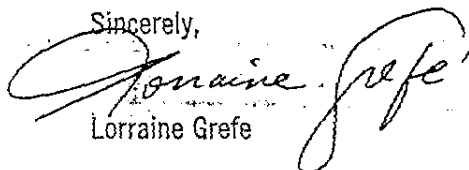
