**AMENDED ARTICLES OF INCORPORATION**  
**FOR**  
**KEEP SOUTH PINELLAS BEAUTIFUL, INC.**

**ARTICLE I NAME**

The name of the corporation shall be Keep South Pinellas Beautiful, Inc.

**ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business and the mailing address of this corporation shall be City of South Pasadena, 7047 SUNSET DRIVE, South Pasadena, FL 33707

**ARTICLE III PURPOSE**

The purpose of this organization shall be charitable and educational within the meaning of Section 501 (C) (3) of the Internal Revenue Code as amended and to promote public interest in the general improvement of the environment within an area known as South Pinellas County; to initiate, plan, direct and coordinate programs for litter control for the community on a sustainable basis; to implement and maintain the Keep America Beautiful System; to study, investigate and develop plans for improving the health, sanitation, safety and cleanliness of the cities and South Pinellas County by beautifying the streets, highways, waterfronts, lots, yards and other places in the said cities and South Pinellas County; to aid in the prevention of fires, diseases and other casualties by the elimination of trash and other debris from the streets, highways, lots, yards and similar places; to encourage the placing, planting and/or preservation of trees, flowers, plants, shrubbery and other object or ornamentation in said cities and South Pinellas County; to protect song birds and other wild fowl; and to advise and recommend plans to other agencies of the cities and county for the improvement of community appearance of the said cities and South Pinellas County.

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS**

The manner in which the directors are elected or appointed is as follows:

Directors shall be elected by the general membership at an annual meeting.

ARTICLE V LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

ARTICLE VI REGISTERED AGENT AND STREET ADDRESS

ARTICLE VII DISSOLUTION

In the event of the dissolution of the corporation, the residual assets of Keep South Pinellas Beautiful, Inc., will be turned over to one or more organizations described in Section 501 (C) (3) and 170 (C) (2) of the Internal Revenue Code or corresponding section of any prior or future law or to be Federal, State or local Governments for exclusive public use.

The above Amended Article of Incorporation were approved and adopted by Keep South Pinellas Beautiful, Inc's Officers and Directors at the Board Meeting held on September 25, 1997. There are no members that are entitled to vote on amendments to Articles of Incorporation.
