Effective August 1st 2004, the PHYSICAL SITE ADDRESS at which you reside or own property will be changed as noted above. All you need to change is your mailing address on your personal mail.

The Post Office will deliver mail to the old addresses for ONE YEAR giving you time to notify all agencies.

This address does not mean you cannot use a Post Office Box within a Post Office, or a central mailbox within a Mobile Home Park or Condominium.

The Post Office will continue to deliver mail addressed to your old number/street name for a period of time to allow you to change your address with minimum of inconvenience.
