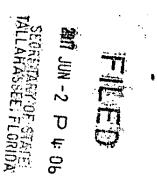

Proposed amendment to Articles of Incorporation of UTOPIA HOMEOWNERS SECURITY ASSOCIATION, INC.

Article VII Board of Directors

Section 1.
