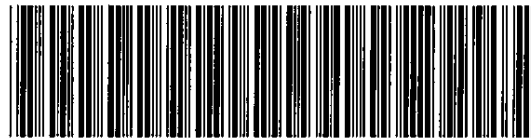

ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
REVELATION MESSAGE, INC.

Pursuant to Sections 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act, the Articles of Incorporation of REVELATION MESSAGE, INC. (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is REVELATION MESSAGE, INC.

SECOND: Article 3 of the Articles of Incorporation is amended in its entirety to read as follows:

The corporation is organized as a corporation not for profit, exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including but not limited to the advancement of the Christian religion as originally taught by Jesus Christ and making those religious teaching available to individuals, churches, fellowships, and ministries. The corporation will accomplish its purposes in the following manner:

(a) The corporation will ordain and issue ministerial certification for Ministers of the Gospel of Jesus Christ who have satisfactorily graduated from an approved Christian Seminary.

(b) The corporation is to oversee the planting and strengthening of member affiliate churches and pastors.

(c) The corporation will provide on-going training through specialized courses, seminars that address issues and challenges of a pastor and/or directing a ministry.

(d) The corporation will provide a vehicle where individuals, churches and ministries are accountable for the decisions, mode of operating and ethics used as they spread the Gospel of Jesus Christ.


(e) The corporation will provide contacts and fellowship between ordained Revelation Message, Inc., ministers in a local area, thus providing a spiritual and professional support system.

(f) The corporation will organize and systematize record keeping activities among affiliate churches for compliance with local, state and federal regulations.

THIRD: The foregoing Articles of Amendment were adopted and approved by the Board of Directors of the Corporation on April 4<sup>th</sup>, 2006, and there are no members of the Corporation entitled to vote on the articles of amendment.
