**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
REVELATION MESSAGE, INC.**

Pursuant to Sections 617.1002 and 617.1006 of the Florida Not for Profit Corporation Act, the Articles of Incorporation of REVELATION MESSAGE, INC. (the "Corporation"), are hereby amended according to these Articles of Amendment:

**FIRST:**           The name of the Corporation is REVELATION MESSAGE, INC.

**SECOND:**       Article 3 of the Articles of Incorporation is amended in its entirety to read as follows:

The corporation is organized as a corporation not for profit, exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, including but not limited to the advancement of the Christian religion as originally taught by Jesus Christ and making those religious teachings available to individuals, churches, fellowships, and ministries. The corporation will accomplish its purposes in the following manner:

(a) The corporation will ordain and issue ministerial certification for Ministers of the Gospel of Jesus Christ who have satisfactorily graduated from an approved Christian program.

(b) The corporation is to assist in the strengthening of ordained pastors and ministers primarily through education. This will include the operation and administration of a Christian Institute, a Christian Bible College, and a Christian Seminary.

(c) The corporation will provide on-going training through specialized courses, that address issues and challenges of directing a ministry or being a pastor.

(d) The corporation will provide a vehicle where individuals, and ministries are accountable for the decisions, mode of operating and ethics used as they spread the Gospel of Jesus Christ.


(e) The corporation will provide contacts and fellowship between ordained Revelation Message, Inc., ministers , thus providing a spiritual and professional support system.

(f) The corporation will provide a Christian based education to the incarcerated. That this education would allow them to impact the lives around them while incarcerated but also would help equip the student once released, not to return to the life style that caused them to become incarcerated.

THIRD: The foregoing Articles of Amendment were adopted and approved by the Board of Directors of the Corporation on December 16, 2009 and there are no members of the Corporation entitled to vote on the articles of amendment.
