**ARTICLES OF AMENDMENT
OF
WINNER'S CIRCLE CHRISTIAN FELLOWSHIP, INC.**

At a meeting of the Officers and Directors of WINNER'S CIRCLE CHRISTIAN FELLOWSHIP, INC., a Florida Corporation not for profit, said meeting having been duly noticed and attended by all of the Officers and Directors of the Corporation, and there being no members of the Corporation, the following amendment was unanimously passed, upon the vote of the Officers and Directors:
