

A meeting of the Crystal Springs Community Association was called on Tuesday, May, 9, 2006 at 7:30 P.M. At that time a vote of No Confidence of Officers was called for. It was passed unanimously by the membership and the existing slate of officers was asked to resign. New officers have been elected. The new officers have been added to the report.
