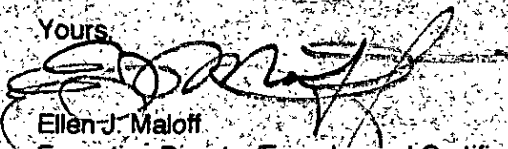
1. Cessation of mail delivery to residences on Grafton Street, Sarasota, FL. I'm enclosing a letter from the US Postal Service regarding. This particular situation was not resolved for 3+ months.
2. A rash of mail theft experienced in this same area and
3. the temporary leave-of-absence of the Secretary/Treasurer of ReLEAF due to a personal crisis. It is she who would have handled this issue.

ReLEAF has been a corporation serving our community since 1992. As you know, not for profit organizations derive their funds from community donations and these monies are donated to us to be used for tree planting, preservation and education. We hope you'll understand our situation and not penalize us monies (\$175) that we believe would serve a better purpose when used to further our mission to

involve the community in tree planting, protection, care and education and by so doing change how our community looks, lower the temperature, clean the air, save water and bring communities together.

We've enclosed a check in the amount of \$61.25 and the appropriate forms which would normally cover our fees for incorporation. We sincerely hope this will be satisfactory.
