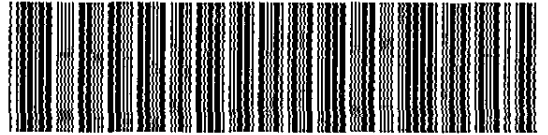

FIRST: Amendment I:




