**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
BRIDGES OF AMERICA, THE ORLANDO BRIDGE, INC.**

THE UNDERSIGNED, Lori Costantino-Brown, President of BRIDGES OF AMERICA,  
THE ORLANDO BRIDGE, INC., a Florida not for profit corporation (the "Corporation"), for  
and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of  
Incorporation of the Corporation:

**ARTICLE FIRST:** The name of the Corporation is BRIDGES OF AMERICA,  
THE ORLANDO BRIDGE, INC., and the Corporation's Florida document  
number is N50274.

**ARTICLE SECOND:** ARTICLE I - NAME of the current Articles of  
Incorporation is hereby deleted in its entirety and restated as follows:

**"ARTICLE I**

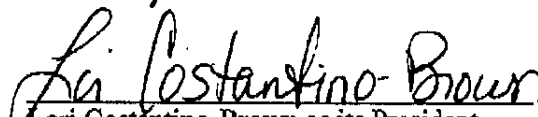
**NAME**
