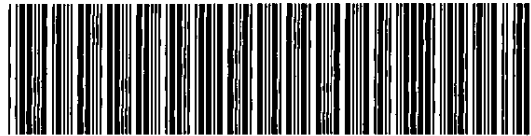

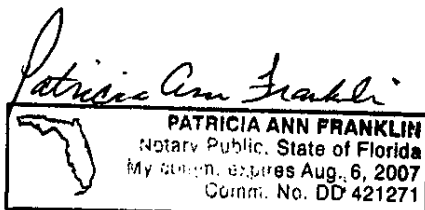
PLAN OF DISTRIBUTION OF ASSETS
