On January 13th, 1999 at about 2:56 pm, I had a telephone conversation with Stacey, a staff member with the Division of Corporations on her phone number of 850 487 6059

We discussed the issue of getting Cedar Creek reinstated. I explained that an acting secretary was removed from his position, which he agreed to, however he either has intentionally misplaced or inadvertently displaced some of our paperwork.

That necessitated that I put in a request with the postmaster to have our post office box changed. The lady who took the request went into the hospital the next day and the request was lost.

I explained to Stacy that we failed to get correspondence from the State and in the confusion did not renew the corporation timely.

Stacey then said to me that if I would explain this in a narrative, she would allow us to reinstate for \$122.50 rather than the much larger amount.
