### ARTICLE X

### AMENDMENT TO ARTICLES OF INCORPORATION

These Articles of Incorporation may be amended in the following manner:

The proposed Amendment shall be adopted upon receiving the affirmative vote of a majority of the votes of the Members-entitled to vote thereon eligible voting interests present, in person or proxy, at a Membership meeting at which a quorum is established.
- D. An-Amendment to these Articles of Incorporation may be made by a written-statement signed by all-Members and Directors eligible to vote in lieu of the above procedure.
